In The Net, 798 Airport Road, Palmyra PA 17078

From the North (Northern New Jersey/New York/Wilkes-Barre/Scranton)

Interstate 78 West to Interstate 81 South to Exit 29a Route 934 South to Route 322 West to Route 117 North.

Turn right on Airport Road.

From the South (Baltimore/York)

Interstate 83 North to Route 322 East at Harrisburg to Route 117 North.

Turn right on Airport Road.

From the East (Southern New Jersey/Philadelphia/Reading)

Pennsylvania Turnpike (Interstate 76) West to Exit 266 to Route 72 North to Route 322 West to Route 117 North.

Turn right on Airport Road.

From the West (Ohio/Pittsburgh/Carlisle)

Pennsylvania Turnpike (Interstate 76) East to Exit 266 to Route 322 West to Route 117 North.

Turn right on Airport Road.
