(this is still the same show site – we are just giving the closest “Physical” address to aid in better GPS guidance)

From the South: Use Interstate 83 or 81 to get to Harrisburg. Take Rt. 322 West toward State College. Exit at the Research Park/Hospital Exit. **Make a right onto Park Avenue, Ag Arena is located right before the third stop light on your right. Look for sign.

From Interstate 80, Exit 161: Take Rt. I-99 South. Then take **Exit 74 Innovation Park/Penn State University** Exit. Stay in left lane for PSU/Beaver Stadium. This lane becomes Park Avenue. Ag Arena is located on the right just before the 4th stop light. Look for sign.

From Altoona take I-99 N / 220N to State College: Take **Exit for Innovation Park/Penn State University / Airport / Hospital** – Stay right on to Park Ave. Ag Arena is located right before the 4th stop light on your right.

Official Measuring will not be available at this trial unless an AKC rep would happen to show up.
