The judge is ultimately responsible for any gate sheet changes during the trial weekend and must be consulted before changes are made.

Judge, club or ring staff are not responsible if you show up late for a walk or run.

Neither the Judge, the Club or the Trial Sec. will be held to anything other than the start time for the first class of the day.

All start times beyond the first class of the day are ONLY APPROXIMATE.

It is the sole responsibility of the exhibitor to be checked in, walk the course and show up on time to run.
